## The Search

The Spencerville Local School District is seeking qualified applicants for the position of Treasurer. This vacancy is the result of the retirement of the current Treasurer after 30 years of service with the district.

## Qualifications

- A valid Ohio School Treasurer License or the ability to obtain one along with public sector financial management experience.
- A comprehensive understanding of Ohio school law, finance and regulations and financial reporting.
- Self-starting skills with a positive team attitude.
- Excellent analytical, listening, verbal and writing skills, and the ability to professionally convey pertinent information to the Board, Staff, and Community.
- The skill and ability to effectively work with the Board, Superintendent, and other District Administrators to serve as a contributing member of the management team.
- Strong multi-tasking skills, with the ability to organize and synthesize information efficiently.
- Ability to utilize technology effectively to ensure timely reports as well communicate with the public.
- Experience with and knowledge of The Ohio Bureau of Worker's Compensation.
- Personal integrity, as well as a record of being loyal, positive, enthusiastic and organized with a strong work ethic.
- Thorough knowledge of and successful experience in sound fiscal management practices.

The Board will provide a competitive compensation package. A multiyear contract with provisions for annual review will be offered. The actual salary and fringe benefits will be commensurate with the education and experience of the candidate.



## About the District

The Spencerville Local School District is located primarily in Allen County, but does have presence in Van Wert and Auglaize counties. The rural District encompasses 90 square miles and is served by State Routes 66, 81, 117 and 198.

In January 2007 the students and staff were moved into a beautiful new K-12 building. Being under one roof has been a tremendous advantage to the educational experience for all. The District transports 50% of its enrolled students.

Major sources of revenue to the District are local property taxes on real and personal property, along with state aid. Other funds, such as lunch and special classes are funded for their expenditures by designated state and federal grants. The District also has a five year 1% school district income tax which is a significant source of revenue for the District.

## The Community

Spencerville is a residential suburb to the southwest of Lima, OH. Spencerville was founded in 1844 on the banks of the Miami-Erie Canal and today has approximately 2,300 citizens.

Lima and surrounding communities have a population of approximately 85,000.

Lima boasts of two fine hospitals: St. Rita's Medical Center and Lima Memorial Hospital. Additional medical facilities include a Cancer Treatment Center, a Coronary Care Unit as well as the Orthopedic Institute of Ohio/Institute for Orthopedic Surgery.
